# **Opening / Devotional / Reciting of Pledge**

The presiding officer, Basileus Wright, called the Alpha Sigma Graduate Chapter meeting to order at 10:17 am. Soror Terrell, Chaplain, led us in prayer and this was followed by reciting the Sorority Pledge.

Sorors introduced themselves to include their name, induction chapter, year inducted, office held (if applicable), and shared travel plans/activities for the summer.

# Adoption of Agenda /Reading of Minutes (Silently)

Basileus Wright called to adopt the agenda. She highlighted that there were some adjustments to the agenda because some reports were not submitted by the Composite publishing deadline. In light of many Sorors needing to leave early to attend a Swim1922 event in Bloomington, IN, a motion was made to modify the agenda to move the New Business Item, 2019-2020 Budget Presentation, to be 1<sup>st</sup> on the agenda. The motion was dully passed. Basileus Wright proposed that the agenda be adopted with the modifications. The motion was dully passed.

## New Business (New Items / Projects Not Yet Discussed)

## 2019-20 Budget Presentation (Composite pgs. 55 - 58)

Soror Clark reviewed the proposed budget for the 2019-20 Sorority Year.

Soror Amos asked a question about IBE participation for this year and the impact of a booth purchase.

Soror McGrady asked a question about budget funding for the Philo affiliate organization. Moved and properly seconded to decrease the budget line item to \$22 for the Philo Club budget line and reallocate balance of funding to the Rhoer Club. A discussion ensued about what happens to budgeted dollars that go unspent. Soror Clayton explained that the unallocated funds get repurposed.

Basileus Wright shared that we can only take on new members for Philos between the months of January and March each year.

Soror Amos indicated that she is opposed to the motion as proposed because going into Centennial, we want to have a complete Sigma family. Soror Turner shared that we currently have between 8 – 10 interests.

Soror Clark highlighted that we had to increase the NPHC budget to accommodate D9 Greek requirements.

Soror Ligon called for a vote and it was properly seconded. The motion to decrease the Philo budget failed.

It was moved and properly seconded that we approve the budget as proposed. The 2019-20 proposed budget was approved.

## **Officer Reports**

## Basileus (Composite pgs. 2 - 3)

Basileus Wright referred to her April and May highlights in her report.

Congratulations to Soror Gilbert as the official Advisor for the BetaBeta Chapter. She will also be making an appointment for the Gamma Zeta Advisor and that call is still open, if you're interested.

Sorors were encouraged to refer to composite for how to engage during off June off-month.

Basileus Wright highlighted the goals she set out for the Executive Board at the start of the Sorority year. In addition, she referred to some of the key accomplishments / highlights for the Sorority year. All Sorors were asked to reflect on what they learned during this Sorority year. She also highlighted chapter successes, chapter improvements for next sorority year, officer challenges, and ways to support her role as Basileus in the upcoming Sorority Year. We're all encouraged to work with Sorors that you haven't worked with before, as this promotes more inclusiveness for the Chapter.

Soror McGrady expressed concerns about the sentiment that has been shared about the "same Sorors being involved all the time." She stated that there are many ways for Sorors to engage and some initiative is required and welcomed.

Soror Cox suggested that we give our Basileus a round of applause for her leadership. The first year is always the hardest and it get sets smoother in year #2.

## Anti-Basileus (Composite pgs. 4 - 13)

Shared the Membership Committee's Awards with those Sorors that were not in attendance for the Awards and Achievement banquet.

Soror Amos welcomed the Neos (Allegiant 18) to their very 1<sup>st</sup> Chapter meeting. Highlighted that we received more than 3k views on social media about Allegiant 18 becoming new members! We're at 135 members for this Sorority year, which represents 19.47% growth rate. We also had 86.73% retention rate.

We received the International Membership Grant to host a Sigma Homecoming event.

We currently have 65 interest. They receive a weekly marketing update to encourage their participation in events.

A question from the floor was about what defines an acceptable level of participation. A motion was made to amend Section B to read "has had no disciplinary action within the last 5 years and no open investigations." It was properly seconded. The amendment passed.

A motion was made to amend the length of time in the Standing Rule from 5 years to 2 years. After discussion, an opposition was expressed to keep the 5 years because if hazing occurs, two years is too short. The amendment failed.

Moved to vote on the Standing Rule in its entirety. The Standing Rule passed.
